Min. 1/21.06.2024: Arrival and registration & membership updates by the coordinator)

Members started by sharing their views about the alcohol control bill.

In Kumi district, people are excited about the proposed Alcohol Drinks Control bill, and they feel we are late. This bill will complement the work UGGA is doing on the ground there.

The 'Health and Trade' committee of Parliament membership (to which we gave our submission on increased taxes) has been changed, and we might be required to make a new submission.

For Ring of Hope, in Busoga, every week, we lose people to alcohol related harms.

The people say the bill is late and should have come long ago.

The alcohol industry is passing on wrong information regarding the bill for a total ban on alcohol.

People are worried about the enforcement of the bill. We shall need to have enforcers on the ground.

Communities are encouraged to work on local regulations. The church is to create more awareness and sensitisation of alcohol related harm to its members, as we wait for the laws.

Schools are not doing well; they need a lot of sensitisation, as things there are getting out of hand. More awareness needs to be concentrated in schools, as we also work with communities.

We are glad that there is a mental health component in the church.

LMI works in the refugee settlement, and they have already kicked off a local regulation.

Min. 2/21.06.2024: Roll call of members -The AGM roll call was done by the General Secretary.

Min. 3/21.06.2024 Opening prayer was led by Joarita Kiwanuka Kiwala of Voice Life Health.

Min. 4/21.06.2024 Review minutes of previous AGM by Ms Mpairwe Prudence

Mr Jabel Mutekanga (Recovery Ministries International) moved the motion that the minutes were a true record of what was discussed.

Ms Afaayo Josephine (Afaayo Anti-Drug Abuse Initiative) seconded the motion.

Min. 5/21.06.2024. Chairperson's report by Ms Juliet Namukasa (reference to the magazine)

UAPA's Strategic areas are -Advocacy. Networking, Capacity building & Sustainability.

We closed the year with 2023 donors, i.e., IOGT NTO Movement, RESET/ Vital Strategies, AstraZeneca/CAF.

She ended by appreciating the Secretariat for the work they do.

She thanked Dr. Kalema for being present today and for always being available. He is also the Chair Board of Trustees.

She thanked the Board of members for the work they do. Thanked our funders, the IOGT NTO movement since UAPA inception, RESET, which has supported our advocacy work on the bill, and AstraZeneca for supporting community work.

She thanked MoH, the Parliamentary Forum of Health, etc.

Challenges

- i. Some members are struggling financially and are unable to subscribe.
- ii. We need to repackage our agenda and look for more funds.
- iii. Sweden changed its funding priorities, and this is affecting our donor, IOGT.

Min. 6/21.06.2024 Financial report -Auditor and Treasurer

Treasurer's Report by Mr Jackson Isabirye

He appreciated members for coming to the AGM.

He reported that UAPA has 3 funders, something that has never happened in the past.

i. IOGT-NTO-MOVEMENTii. RESETiii. AstraZeneca800,000 SEK50,000 USD10.000 USD

He appreciated the Secretariat and Board members,

He encouraged members to pay their subscription. All our projects are closing at the end of the year, implying that we need to raise funds, especially during this period when we are advocating for the bill. Strategies for more resources include writing proposals.

Presentation from Kalinda and Advocates by Ms Mirabel Masaba

She commended the great work UAPA and its members are doing.

The Auditor reported that UAPA's audit report is unqualified. Implying, the financial statements are accurate, complete, and fairly presented by the applicable accounting standards. There were no significant errors, misstatements, or irregularities found in the financial records. They determine that there are no key audit queries to report. Proper books of accounts were kept.

Mr Jonah Egwayu (Somero Uganda) passed a motion that we adopt the report, Ms Asaba Linda (UHCA) seconded the motion.

Reactions

- Members wanted to know what the money saved was used for.
- They were informed that it was utilised.
- A member inquired about the subscription stand and how they are utilised.
- 26 paid-up members as of 2023.
- Some people have arrears from 2019.

Min. 7/21.06.2024, Matters Arising

For increased membership, one member proposed that each one interest at least two new people.

An announcement about the conference was made, i.e it will be from 27th -29th November 2024 at Hotel Africana.

Min. 8/21.06.2024 Empowerment session, Presentation from Counsel George Muwanguzi.

Why is the Alcohol Control Bill important?

- i. The bill is for Uganda.
- ii. It's based on law and policy.
- iii. Uganda has a policy on alcohol since 2019.
- iv. Uganda has been operating on an absolute alcohol law

Updates

- i. Alcohol is causing a lot of damage, including diseases such as cancer.
- ii. 30% of Ugandans between 18-69 use/ drink alcohol.
- iii. We have a push bank and it's entirely on profits.
- iv. In many countries, alcohol is regulated.
- v. The USA has set a minimum legal age of 21 and set it at the federal level so that all states comply.
- vi. Hours of sale of alcohol in public bars and clubs are restricted, mainly to afternoon and not beyond 11 pm or midnight.
- vii. Issues of advertisement are also addressed. False and misleading adverts are prohibited.
- viii. Responsible authorities- Ministries and licensing authorities have residual powers to make regulations.

Lessons for Uganda

- i. Uganda needs an alcohol control law
- ii. Current law needs strengthening.
- iii. The element for alcohol abuse-related conditions, treatment and rehabilitation is missing.
- iv. Element of monitoring, research and information sharing
- v. Stakeholders may need to reassess the issue on enforcement.
- vi. Members appreciated this initiative of building members' capacity.
- vii. Members asked who we go to for this bill to be approved.
- viii. Alcohol is not a beverage.
- ix. If alcohol is a drug, why is it that UNBS is certifying it, not NDA?
- x. How often are the fines reviewed?

Min. 9/21.06.2024, Discussions to review subscriptions and membership fees

A report was given to the AGM that some members have not updated their membership, thus the local funds realised are not enough to run the secretariat. Below are the proposals for increasing local income;

- i. Increasing membership from 100,000 to 150,000.
- ii. Increasing annual subscription from 60k -100k for organisations.
- iii. Increasing members' benefits
- iv. Interesting more members.
- v. Waive subscription for organisations that lost funding and have not yet paid the subscription.
- vi. Following up defaulters individually and not as a group.
- vii. Doing a needs assessment to know why people are not paying.

Members made a motion to vote on the issues raised. Members voted for these;

ACTION POINTS:

- i. Needs assessment- to get the feedback and to know what is driving our members away. Form to be shared.
- ii. Increment for the organisation's membership from 100,000 to 150,000 and annual subscription from 60,000 to 100,000
- iii. Frequent reminders to members to pay subscriptions.
- iv. Putting a deadline for payment of subscription fees and putting a surcharge for late payments.
- v. Need
- vi. Organisational visit, send an email, online engagement, phone call, by the Secretariat by the end of August.

Min. 10/21.06.2024 Elections of new office bearers, in the even year, three positions fall vacant:

- 1. Chairperson
- 2. General Secretary
- 3. Treasurer

iii. In a good spirit, Ms. Joanita Kiwanuka Nakiwala proposed to step down for the position of General Secretary, leaving one candidate for this position. Ms. Aturinde M. Prudence went through.
