Introduction

- Alcohol packaging (small/big) has had a impact on consumption levels in different parts of the world leading to higher consumption and harm (Morojele et al. 2021
- Muluya et al., 2014).
- It was good news when Sachets of alcohol were banned in Malawi in 2015 and Uganda in 2019
- Other countries that have banned sachets: Ivory coast (2016), Tanzania (2017), Kenya (2005), Cameroon (2014), Senegal (2019), Nigeria (planning to 2020)
- Paucity of documentation; policy analysis of these bans that can inform other policy changes in other countries







There is still limited literature on the formulation and implementation of sachet (& small packaging of alcohol) bans or policies In Uganda and Malawi

So what do we plan to do?

Study aims

1- To understand the adoption and formulation of the bans, what mechanisms for implementation were proposed and put in place, how the bans were enforced in practice, as well as stakeholder and public perceptions of, and explanations for, intended and unintended consequences of the bans.

2-To explore contextual factors important for the transferability of findings to other Sub-Saharan countries, in order to inform alcohol policy development and implementation across the region.



Study's work packages: WP1.1 and WP1.2

WP1.1: A Documentary analysis of all main documents related to sachet bans in Malawi and Uganda (consultation documents, policy documents, court rulings, regulations or legislation etc) We are using all our networks in country to identify key documents.

WP1.2: Key informants interviews (~9 in each country) with key National/district officials), to deepen our understanding of the rationale, context and process of the bans, as well as intended enforcement mechanisms.



Study's work packages:WP2

In depth interviews with district and local kevel stakeholders (~10 in each country) responsible for the enforcement of the bans (e.g. Ministry of Trade and Industry, Bureau of standards, Police etc.) at either district or local level.

To understand experiences of the enforcement and implementation of the ban in each country(inc. respective roles, enforcement effort & experience, barriers and facilitators to enforcement, intended and unintended consequences)



Study's work package: WP3

Focus group discussion with community members (~9 groups in each country; Wakiso (some in Gulu) in Uganda and Blantyre in Malawi)--At least 3 groups with 16-18 year olds (with parental assent), who have had experience of sachets consumption (including in their networks) prior to the ban. Other groups with health staff from local health centres or hospitals and with traditional/ church leaders/school headteachers local CBOs.

<u>To Understand</u> the problem of consumption of alcohol sachets/ small packaging before and after the ban; lived experiences of the ban(perceived positive and negative impact including on patterns of consumption; any unintended consequences (alternative products consumed; home-produced or illicit alcohol; economic impact); perceived changes in levels of addiction/harm.

- Stakeholder mapping and WP1.2/ WP2 preparations: country leads & RAs establishing sampling and mapping stakeholders in each country
