### Highlights of 2019

Almost all the planned activities for the different strategic areas in 2019 were implemented.

1. UAPA is actively contributing as a member in the technical group towards the approval of the National Alcohol Control Policy (**NACP**) and the enactment of the new alcohol law
  - Lobbying meetings with relevant legislators
  - Advocacy meetings with key Government agencies and selected ministries.
  - Production and dissemination of alcohol control advocacy materials.
  - Regular meetings with Ministry of Health to review progress.
  - Stakeholders meetings to review the draft National Alcohol Policy.
2. More partners / organizations participating in alcohol advocacy work.
  - Participation in International conferences and forums for advocacy against alcohol.
  - Annual General Assembly for UAPA members.
  - UAPA members trained in Advocacy and supported to gain skills in their (alcohol control related) areas of operations.
  - General capacity building activities.
3. Strengthening the UAPA membership and internal control processes for to demand for the necessary legislative intervention.
  - Formulating operating manuals (Finance, operations and human resource).
  - Quarterly meetings of UAPA Executive.
  - Prompt Payment of rent, Salaries, allowances and appropriate taxes.

### Other activities

- Conducted quarterly board meetings.
- UAPA facilitated a stakeholder meeting and a retreat that drafted and finalized

the draft National Alcohol Control Bill (NACB).

- UAPA offered moral, technical and sometime financial support to her members to keep them interested in the network activities. A few examples include; co-sponsoring Alcohol conferences, participating in alcohol harm awareness through sports and music and speaking at the alcohol prevention functions organized by her members.
- Increasing membership and commitment: UAPA AGM recruited nine new members; five organizations and four individuals hence the annual target of 30 members was achieved in the first quarter. We conduct site visits to member organization to strengthen the alliance relationship. We have constantly consulted them regarding the governance issues and have kept our key stakeholders informed of our plans. We have also continued to recruit new members.
- UAPA organized several forums that brought together different stake holders and these were pivotal in yielding intended results. Such included the technical working group and core group of alcohol researchers to write the NACB. UAPA further facilitated a breakfast meeting to launch the multisectoral committee to ban alcohol in Uganda.
- To enhance competency and credibility in provision of alcohol prevention services, 19 UAPA members were equipped with Addiction treatment skills during the training on Universal Treatment Curriculum for Addiction Professionals and 10 were successfully accredited as International Addiction Professionals.



UAPA sat the 6th Annual general assembly on 26th April 2019 at Grand Global Hotel, to deliberate on the issues pertaining the alliance, electing new leaders, amended the constitution, discussed policies, received and endorsed the new work plans and budget for the new year. 2020 AGM has been delayed by the COVID 19 epidemic.

**Press release on the occasion to commemorate the 'International Day against Drug abuse and Illicit Trafficking'**

**Theme:** "Health for Justice. Justice for Health"

On Tuesday, June 26, 2019, Uganda will join the rest of the world to commemorate the *International day against drug abuse and illicit trafficking*. This year's theme "Health for Justice. Justice for Health" emphasizes the integrated nature of the rights- and health-based approaches.

Psychoactive drugs are chemical substances that affect the functioning of the central nervous system, altering perception, mood or consciousness. Common examples of such drugs that are commonly used in Uganda include; marijuana, khat, petroleum products, heroin, cocaine, prescription drugs among others. Alcohol is the commonest drug used and its negative impact is experienced across the globe.

**Alcohol: A dangerous psychoactive substance**

According to World Health Organisation (WHO), harmful use of alcohol is responsible for 3.3 million deaths i.e. 5.9% of all deaths every year. The latest Global Alcohol Status Report of the World Health Organization (WHO) shows that countries in Africa are now bearing the heaviest burden of alcohol-related disease and injury – even though other continents are still consuming more alcohol in total.

**Alcohol use problems in Uganda**

WHO highlights Uganda as a country with hazardous drinking patterns due to high prevalence of alcohol consumption and heavy episodic and underage drinking. Uganda's alcohol per capita consumption of 9.8 liters, is among the highest in Africa (Africa's average is 6 litres). Most of the alcohol produced/ consumed is illicit. In 2011, a worldwide survey of socio-economic consequences of alcohol consumption reported Uganda as the country with the highest rate of alcohol-related negative consequences among listed drinkers. Alcohol is documented to destroy families and communities; burden productivity and keep children and youth from living up to their fullest potential which ultimately slow the socio-economic development of the country.

As emphasised by this years' theme, failure to substantially reduce alcohol use and related harms threatens progress not only in health, but in social justice, economic productivity and in sustainable development. Without urgent action, the alcohol burden is only going to rise and the death toll shall never stagnate.

**Key achievement in the fight against alcohol harm in Uganda**

UAPA is an umbrella organization for individuals, organizations and communities (without commercial interests) advocating for reduction of alcohol harm through effective regulation in Uganda. For the last 10 years UAPA has worked with various stake holders (most closely with Ministry of Health, Makerere University School of Public Health and UAPA members) to support alcohol regulation that has contributed to some important steps in controlling alcohol harm.

- Packaging and selling of sachet alcohol is banned.
- The National Alcohol Policy is awaiting cabinet approval and
- A draft National Alcohol Bill is in ready for input of different stakeholders.
- Various communities (local councils especially in Northern Uganda) have come up with alcohol bylaws/ordinances and related control measures


It is expected that the above steps will ultimately reduce the burden of alcohol related death, disease and disability in Uganda.

### Recommendations

UAPA further calls on the government to move with speed to enforce the Policy and Legislative regulations for the cut back on alcohol and protection of alcohol abstainers. Local leaders without bylaws should emulate others that have alcohol ordinances in order to control alcohol harm among their populations. As it appears that sachet alcohol is still being sold in some parts of the country, there should be more involvement of the private sector to strengthen the monitoring and implementation and ensure that the public is sufficiently involved and empowered to implement this directive. Finally, UAPA urges our population to unite against alcohol harm.

## Cartons of alcohol seized in a government joint operation!

NewVision 3<sup>rd</sup> October, 2019

The Uganda National Bureau of Standards (UNBS), in a joint operation with Uganda Revenue Authority, Ministry of Trade Industry and Cooperatives and the Uganda Police have seized over 400 liters of alcohol packed in bottles less than 200mls, worth 7.4 million shillings in the Kampala City Centre. Alcohol brands like Lords Blended Malt Whiskey, Royal Circle Whiskey, Legend Whiskey, Mr Doweel's, Blue Skyz Vodka, Uganda Waragi, Bond 7, Beckam gin, Herdsman blended Whisky, Red Sorghum Whiskey and Twebeleremu Extra gin, packed in 180mls and 100mls bottles.

## Cabinet approves National Alcohol Control Policy

NewVision September 24<sup>th</sup>, 2019

Cabinet has approved the National Alcohol Control Policy that is aimed at, among others, raising community awareness about the magnitude and determinants of the health, social and economic problems associated with harmful use of alcohol.

Mr Ssubi Kiwanuka, the public affairs officer at Uganda Media Centre, told journalists on Tuesday, September 24, 2019, that the policy carries other objectives such as enhancing capacity and increasing technical support for prevention of harmful use of alcohol and management of associated alcohol disorders.

The policy also demonstrates the government's commitment to address the alcohol-related harm using effective evidence-based intervention.

The government also intends to strengthen regulation on production, packaging, distribution, marketing, sale and consumption of all alcohol beverages.

In 2017, Parliament revived a private member's Bill that seeks to regulate the alcohol industry. The Alcoholic Drinks Control Bill, 2016, is a brainchild of Betty Nambooze, the Mukono Municipality Member of Parliament.

The current Liquor Act, Cap. 93 Section 19 places a restriction upon the license not to allow persons under the apparent age of 18 to be in a bar or licensed premises during the period of sale and consumption of alcohol

UAPA delights in the government's decision to ban sachet alcohol which has been a longstanding major concern for UAPA and the country at large. To recognize efforts of civil society in this struggle, UAPA was elected to represent the civil society on the multi sectoral committee for monitoring the enforcement of the ban which was launched by Minister of trade Industry and Co-operatives on 10<sup>th</sup> September 2019. Some of the benefits of this ban was the sealing of all industrial production plants for sachet alcohol by Ministry of Trade Industries and cooperatives. There are

also various reports where sachet alcohol has been impounded and destroyed. For instance, in on October 3<sup>rd</sup> UNBS, URA and Uganda Police seized 400 liters valued at 7.4 million shillings in Kampala. On October 10<sup>th</sup>, URA impounded 10 cartoons (2,640MLs) of illegal alcohol at Katuna boarder on its way to Kenya. Other efforts were reported at local levels where leaders jointly worked to stop the sale of sachet alcohol in their places.



# UAPA to represent CSOs on the Multi sectoral committee supervising the implementation on the ban on Alcohol

## 1.0 BACKGROUND INFORMATION

Evidence available indicates that Uganda is one of the top African Countries with a high consumption rate of alcohol. Currently, Alcohol consumption in Uganda level is 9.8 litres per capita and it is higher (14.4 litres) among men than women (5.2 litres). In addition, there is high prevalence of heavy episodic drinking, underage drinking and consumption of illicit or informal alcohol.

Excessive consumption and abuse of alcohol has detrimental effects on humans. The effects include as mental and behavioral disorders, liver and cardiovascular diseases, and injuries, violence, public endangerment and death.

To address the above problem and protect the under age and youth from devastating effects of alcohol abuse; increase labour productivity; minimize injuries and traffic accidents; Government through Cabinet in 2017 under Cabinet Minute 128 (CT 2017) took a decision to ban the packaging of alcoholic drinks in small pocket size sachets.

The Ministry of Trade, Industry and Cooperatives was directed implement the ban and ensure factories involved in the production and packaging of alcoholic drinks to transit from packaging in plastic sachets to packaging in plastic and glass bottles of 200 millilitres (mls) and above. The transition process required acquisition of new technology of bottle filling and packaging by the factories. This posed a challenge to industry in the first year to achieve and was completed in February, 2019 with more than 80% compliance. However, for ensuring complete transition and sustainability of the gains, the promised to establish a multi sectoral taskforce to monitor the enforcement and curtail any efforts by some dealers to continue producing or importing alcoholic drinks packaged in sachets.

## 2.0 COMPOSITION OF THE TASKFORCE

Effective coordination and enforcement requires collaboration and commitment from various stakeholders in Government and Private sector. The taskforce is comprised of technical officers from the following institutions;

- i. Ministry of Finance Planning and Economic development
- ii. Ministry of Trade, Industry and cooperatives
- iii. Ministry of Local Government,
- iv. Office of the President
- v. Ministry of Health,
- vi. Ministry of Works and Transport,
- vii. Uganda National Bureau of Standards,
- viii. Uganda Investment Authority
- ix. Uganda Revenue Authority

- x. Civil Society organization/Uganda Alcohol Policy Alliance
- xi. Uganda Manufacturers Association.

## 3.0 RESPONSIBILITIES

The taskforce will be required to undertake the following activities;

- i. Review the effectiveness of sector specific interventions contributing to the enforcement of the ban and advise the institutions concerned accordingly,
- ii. Create awareness in the respective sectors and general public on the dangers resulting from excessive alcohol consumption and abuse,
- iii. Share information to support market and factory surveillance operations of designated regulators,
- iv. Promote implementation of standards and best practices in manufacturing to increase compliance and competitiveness of the subsector Undertake surveillance to all factories and seal off production units and equipment designed to package alcoholic drinks in quantities of less than 200mls;
- v. Stop clearing of exports and imports of alcoholic drinks packaged bottles of less than 200mls
- vi. Curtail trading in alcoholic drinks packaged in bottles of less than 200mls on the domestic market including clearing exports for the same.
- vii. Curtail production and trading in illicit/informal alcoholic drinks.

## 4.0 WORKING

The committee will hold quarterly to review progress. Extra Ordinary meetings can be invited in a period of not less than 5 days to address any emerging issues.

## 5.0 FUNDING

Activities approved by the taskforce will be communicated to concerned Accounting Officers for prioritization and funding through Ministry of Trade, Industry and Cooperatives- Chair of the Committee.

## 5.0 REPORTING

The taskforce shall report to the Minister of Trade, Industry and Cooperatives and the Minister of Health through their respective Permanent Secretaries. The taskforce will be chaired by the Commissioner Industry and Technology.

## Pader

Leaders of Pader district launched a ban on alcohol made from molasses. This came after four people lost their lives after taking Alcohol the previous week. We really need to count the economic, social and physical loses due to Alcohol. In this we ought to do a lot more as a platform to address it. Much as there is unemployment, sober people can think more creatively to lessen the burden of poverty on families due to Alcohol.

# International Aid Services (IAS) Uganda

This has gone a long way in transforming the lives of the communities.

134 were registered in 2019 alone – the highest number of beneficiaries registered in one year. To extend treatment to low income populations, HaB pioneered a free treatment camp which attracted 53 beneficiaries with various physical, emotional, behavioural and psychiatric illnesses. On the research and information dissemination front, we shared our findings in local and international conferences and managed yet another peer reviewed publication this time on ‘Predictors of recovery’ which was published by the Journal of Alcoholism Treatment Quarterly. Finally we are glad to have pioneered a package to care for the children of our clients and now ready to share this good practice with other service providers.

The primary mission of Hope and Beyond (HaB) is provision of high quality, holistic and evidence based addiction recovery services so as to restore hope to those who are discouraged by challenges relating to use of alcohol and other drugs. Since formation in 2012, HaB has established herself as a pioneer organisation to combine treatment and research for alcohol use disorders in Uganda. In 2019, HaB made several strides towards expansion of her services. Beneficiaries of our treatment services increased to a cumulative total of 495 clients of which

HaB's theme for 2020 is ‘Arise and Shine’. Besides our regular programming, we plan to pay extra attention to resource mobilisation for building a centre of ‘excellence for addiction treatment and other mental health service’ and continue with treatment camps and research activities. For capacity building, HaB has partnered with Uganda Counsellors’ Association to offer Universal Training Curriculum for addiction treatment professionals.

## Youth Sensitization Outreach



On 3rd December 2019 at Mpewo Valley, Kanyanya, Nnina Olugero Foundation and her partners organised a dancing competition to reach out to the youth who are involved in music, dance and drama to educate them on the peer influence, dangers of abusing drugs, alcohol, early unprotected sex and how to prevent them and their effects.

Kanyanya is a peril urban suburb of Kampala with a number of unemployed youth who use leisure activities such as sports, drama, dancing and music as a source of income, which can't sustain them for a living.

These youth are influenced by peers to start abusing drugs, alcohol and sex which increases their risk to mental damage, STDs, unwanted pregnancies and crime. Uganda Alcohol Policy Alliance (UAPA) was represented by Margret who educated the youth on peer influence, dangers of abusing drugs, alcohol and how to prevent them and their effects. Uganda Police was represented by Afande Fatumah who educated the youth on how to avoid crimes and the different types of offenses. The 3 winning teams were rewarded with Bluetooth speakers to aid them in proper training to boost their talents. This activity proved to be effective because it mobilised more youths in the community especially school dropouts therefore we need to have such competitions to attract more youth mostly in slums.

The Director KYDA, giving remarks about the role of the public on child protection and promotion of children's rights in relation to alcohol.

Our current Alcohol project works to Protect the rights of children from the illicit use of drugs. According to the UN convention, children should be protected from using drugs. Therefore KYDA works with children who are not in their families get protected especially children on the streets because they are in the open space.

KYDA also uses family therapy sessions to help some families with in Kawempe slum community reduce and avoid the use of drugs especially by parents because in one way or the other children get affected. Some few families have positively reacted to the therapy and have started avoiding
